## 1/ INTRODUCTION

BlackDragon website (blackdragon.io, app.blackdragon.io and research.blackdragon.io) is owned and operated by BD Innovation Hub d.o.o. ("BlackDragon," "we," "us" or "our"). These Terms of Use (these "Terms") govern your access to and use of the BlackDragon website; including without limitation the analysis, purchase, sale, exchange, pooling or investing into certain digital assets ("Contribution"); our online and/or mobile services, and software provided on or in connection with those services (collectively, the "Service").

You may use the Service by linking your digital wallets on supported bridge extensions such as MetaMask. MetaMask is a non-custodial digital wallet, which allows you to purchase, store, and engage in transactions using cryptocurrencies.

ALL TRANSACTIONS INITIATED THROUGH OUR SERVICE ARE FACILITATED AND RUN BY SUCH THIRD-PARTY DIGITAL WALLET EXTENSIONS, AND BY USING OUR SERVICES YOU AGREE THAT YOU ARE GOVERNED BY THE TERMS OF SERVICE AND PRIVACY POLICY FOR THE APPLICABLE EXTENSIONS.

BLACKDRAGON IS A CONTRIBUTION PLATFORM. WE ARE NOT A BROKER, FINANCIAL INSTITUTION, OR CREDITOR. THE SERVICES ARE AN ADMINISTRATIVE PLATFORM ONLY. - A. If you wish to participate in a Contribution, you will need to connect a digital wallet to serve as an account on the Service (“Account”). By connecting an Account, you agree to maintain required amount of locked BlackDragon Tokens or BDTs (token contract address: 0x4Efe8665e564bF454cCF5C90Ee16817F7485d5Cf) in the connected digital wallet which amount will serve as an indicator of the Level status (Level 0 = 250 BDT, Level 1 = 1000 BDT, Level 2 = 5000 BDT, Level 3 = 10000 BDT). Maintaining at least 250 BDT locked is the prerequisite to access the Deals part of the website which lists featured projects available for Contribution.
- B. BlackDragon may require you to provide additional information and documents at the request of any competent authority or in case of application of any applicable law or regulation, including laws related to anti-laundering (legalization) of incomes obtained by criminal means, or for counteracting financing of terrorism. BlackDragon may also require you to provide additional information and documents in cases where it has reasons to believe that:

- G. The Service will rely on third-party platforms such as MetaMask to perform the transactions for the Contribution of Crypto Assets. If we are unable to maintain a good relationship with such platform providers; if the terms and conditions or pricing of such platform providers change; if we violate or cannot comply with the terms and conditions of such platforms; or if any of such platforms loses market share or falls out of favor or is unavailable for a prolonged period of time, access to and use of the Service will suffer.

#### **15/ DISPUTE RESOLUTION & ARBITRATION**

- Dispute Resolution. Please read the following arbitration agreement in this Section ("Arbitration Agreement") carefully. It requires you to arbitrate disputes with BlackDragon and limits the manner in which you can seek relief from us.
- Applicability of Arbitration Agreement. You agree that any dispute or claim relating in any way to your access or use of the Service, to any products sold or distributed through the Service, or to any aspect of your relationship with BlackDragon, will be resolved by binding arbitration, rather than in court, except that you or BlackDragon may seek equitable relief in court for infringement or

other misuse of intellectual property rights (such as trademarks, trade dress, domain names, trade secrets, copyrights, and patents).

The arbitration proceeding will not be consolidated with any other matters or joined with any other cases or parties. The arbitrator shall have the authority to grant motions dispositive of all or part of any claim. The arbitrator shall have the authority to award monetary damages and to grant any non- monetary remedy or relief available to an individual under applicable law, the arbitral forum's rules, and the Terms (including the Arbitration Agreement). The arbitrator shall issue a written award and statement of decision describing the essential findings and conclusions on which the award is based, including the calculation of any damages awarded. The arbitrator has the same authority to award relief on an individual basis that a judge in a court of law would have. The award of the arbitrator is final and binding upon you and us.
- **Waiver of Trial.** YOU AND BLACKDRAGON HEREBY WAIVE ANY CONSTITUTIONAL AND STATUTORY RIGHTS TO SUE IN COURT AND HAVE A TRIAL. You and BlackDragon are instead electing that all claims and disputes shall be resolved by arbitration under this Arbitration Agreement. An arbitrator can award on an individual basis the same damages and relief as a court and must follow these Terms as a court would. However, there is no judge or jury in arbitration, and court review of an arbitration award is subject to very limited review.
- **Waiver of Class or Other Non-Individualized Relief.** ALL CLAIMS AND DISPUTES WITHIN THE SCOPE OF THIS ARBITRATION AGREEMENT MUST BE ARBITRATED ON AN INDIVIDUAL BASIS AND NOT ON A OR COLLECTIVE CLASS BASIS, ONLY INDIVIDUAL RELIEF IS AVAILABLE, AND CLAIMS OF MORE THAN ONE CUSTOMER OR USER CANNOT BE ARBITRATED OR CONSOLIDATED WITH THOSE OF ANY OTHER



CUSTOMER OR USER. If a decision is issued stating that applicable law precludes enforcement of any part of this subsection's limitations as to a given claim for relief, then that claim must be severed from the arbitration and brought in the state or federal courts located in the Republic of Croatia. All other claims shall be arbitrated.

- Severability. Except as provided in this Section 15 if any part or parts of this Arbitration Agreement are found under the law to be invalid or unenforceable, then such specific part or parts shall be of no force and effect and shall be severed and the remainder of the Arbitration Agreement shall continue in full force and effect.
- Survival of Agreement. This Arbitration Agreement will survive the termination of your relationship with BlackDragon.
- Modification. Notwithstanding any provision in these Terms to the contrary, we agree that if BlackDragon makes any future material change to this Arbitration Agreement, you may reject that change within thirty (30) days of such change becoming effective by writing to BlackDragon at the following address:

If any term, clause or provision of these Terms is held invalid or unenforceable, then that term, clause or provision will be severable from these Terms and will not affect the validity or enforceability of any remaining part of that term, clause or provision, or any other term, clause or provision of these Terms.

## **19/ SURVIVAL**

The following sections will survive the expiration or termination of these Terms and the termination of your Account: all defined terms and Sections 1-4 and 7-19.

## **20/ MISCELLANEOUS**

These Terms constitute the entire agreement between you and BlackDragon relating to your access to and use of the Services and Content, and your participation in the Contribution. These Terms, and any rights and licenses granted hereunder, may not be transferred or assigned by you without the prior written consent of BlackDragon prior, concurrent or subsequent circumstance, and BlackDragon's failure to assert any right or provision under these Terms shall not constitute a waiver of such right or provision. Except as otherwise provided herein, these Terms is intended solely for the benefit of the parties and are not intended to confer third party beneficiary rights upon any other person or entity.
